1560 CORRESPONDENCE

- (a) Dorset Council Bournemouth, Christchurch, Poole & Dorset Mineral Sites Plan 2019 & Waste Plan 2019 Members NOTED the adoption of the Plans with effect from 31st December 2019.
- (b) Dorset Council Town Engagement Dorset Local Plan

The Town Clerk advised of an invitation received to an event Dorset Council were hosting on

Friday 6th March at South Walks House to which two representatives from the Town Council were invited. The event commenced at 10.00am and would focus on input into the formation of key aspects of the Dorset Local Plan. Cllrs Cheeseman and Mrs Page expressed an interest in attending.

1561 PUBLIC TRANSPORT

(a) De-registration of No. 6 bus service

Members were circulated with a copy of a draft statement prepared by Bridport Town Council on the withdrawal of Bus Services in West Dorset and **SUPPORTED** the sentiments.

Cllr Turner reported on the public meeting held the previous evening, attended by 100 plus bus users, the collection of evidence to support re-instatement would continue. He was delighted to report the CB3 had been praised for the service it provided. Cllr Langridge advised the subject had been discussed at a recent BAVLAP meeting and a letter would be sent to Chris Loder MP.

1562 PUBLIC RIGHTS OF WAY

(a) Dorset Council – Notice of Modification Order

Members **NOTED** confirmation of the Order, made on 24th January 2020, to modify the definitive map and statement by adding a Byway Open to All Traffic (to be numbered Byway 97, Beaminster) and the upgrading of Bridleway 35 to a Byway Open to All Traffic.

1563 HIGHWAY ISSUES

(a) Dorset Council – Proposed works – Hogshill Street

Members had previously been advised of the closure of Hogshill Street overnight between 30^{th} March and 1^{st} April 2020 to allow for maintenance work and **NOTED** the amended official diversion route in connection with the closure.

(b) Blocked Gullies – Whitcombe Road

The Town Clerk advised the problem had been reported to the highway team and works instructed.

(c) Beacon – Pedestrian crossing

The Town Clerk to report one of the beacons appeared to have stopped working.

(d) Fencing - 9 The Square

The Town Clerk was asked to obtain an update with regard to the fencing at the entrance to Fleet Street.
